2016-17 Diamond Peak Uphill Season Pass Waiver of Liability

PLEASE READ, INITIAL AND SIGN

SEASON PASS PRIVILEGES: I understand that my 2016-17 Diamond Peak Ski Resort (DPSR) Uphill Pass must be worn visibly at all times when on the mountain. DPSR makes no guarantees with respect to the duration of the season. DPSR, at its sole discretion, will determine the length of the season based upon snow conditions and other variables. Usage of an Uphill Pass is granted only to the individual to whom it is issued. Any fraudulent use of the Uphill Pass will result in prosecution to the fullest extent of the law. Conducting any kind of business on DPSR property without written consent from an authorized representative of DPSR is not permitted (ie: Ski Instructing, Retailing, Peddling Goods and/or Services) on DPSR property and any person(s) caught conducting acts of this kind or of similar nature will be prosecuted. The Uphill Pass as well as all products granting admission to DPSR are property of DPSR and may be confiscated, revoked, or suspended at the discretion of an authorized DPSR employee at any time for failure to adhere to any of the rules listed above or exhibiting unsafe skiing / riding practices, endangering oneself or others, causing a nuisance / disturbance to the public, and for any misconduct of Incline Village General Improvement District (IVGID) property, facilities and/or staff or statutes.

LOST, STOLEN OR FORGOTTEN PASSES: A \$5 FEE will be charged to replace a lost or stolen Pass. All Uphill Passes will be replaced only at the Diamond Peak Guest Services window.

ASSUMPTION OF RISKS: I understand that there are certain inherent risks in skiing, snowshoeing and snowboarding that are an integral part of these sports, whether natural, man-made or man-modified, as defined in Washoe County Ordinance 864 which includes, but is not limited to: changing weather conditions, variation or steepness of terrain, snow or ice conditions, surface or subsurface conditions, bare spots, creeks, gullies, forest growth or rocks, stumps, lift towers and other structures and their components, collision with other skiers or snowboarders and obstacles and a skier's or snowboarder's failure to ski / ride within their own ability. I further understand that participation in the sport of skiing, snowshoeing and snowboarding may be exposing me, my spouse and/or my minor child/children to these risks which could result in bodily injury, death, and/or property damage, and I assume these risks. I have read, understand, and signed the Uphill Policy acknowledging the details, risks and hazard inherent uphill use at DPSR. Anyone leaving the DPSR boundaries must assume full risk & by their action releases DPSR from any claim.
